External Business Environment has a major role in influencing managerial decision making, processes and organizational structures (Keats and Hitt, 1988). In this case, the competitiveness of SMEs in Indonesia is still very low and vulnerable to the dynamics of the business environment that is increasingly uncertain. The dynamics of the environment is so fast these conditions impact the resulting low productivity and business existence is threatened. This is due to lack of adaptation and responsiveness of SMEs in facing the challenges of the external business environment, due to the limited internal capability possessed.
